# **ANNUAL REPORT – 2021**

## **CHAPTER – 1**

### **Introduction**

திருக்குறள்  
எண்:1022

Meaning : One's family is raised by untiring perseverance in both effort and wisdom.

The Right to Information Act 2005 (Central Act 22 of 2005) is one of the most significant legislation enacted by the parliament of India and came into effect from 12<sup>th</sup> October 2005. This Act has empowered the Citizens to actively participate in the democratic governance and also guaranteed transparency and accountability in every public authority.

### **The Preamble of the Act states**

WHEREAS the Constitution of India has established democratic Republic;

AND, WHEREAS democracy requires an informed citizenry and transparency of information which are vital to its functioning and also to contain corruption and to hold Governments and their instrumentalities accountable to the governed;

AND, WHEREAS revelation of information in actual practice is likely to conflict with other public interests including efficient operations of the Governments, optimum use of limited fiscal resources and the preservation of confidentiality of sensitive information;

AND, WHEREAS it is necessary to harmonise these conflicting interests while preserving the paramountcy of the democratic ideal;

NOW, THEREFORE, it is expedient to provide for furnishing certain information to citizens who desire to have it.

An Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority was therefore enacted by Parliament in the Fifty-sixth year of the Republic of India which provides for

the constitution of a Central Information Commission and State Information Commissions for matters connected therewith or incidental thereto.

The Right to Information Act aims to eliminate corruption and make democracy work for the people in the real sense. It mandates a timely response to the requests of citizens for Government information.

## **Chapter – 2**

### **2.1 .Salient Features of the Right to Information Act, 2005**

- (i) Any citizen of India can seek information from any public authority and he / she need not specify the reason for the same.
- (ii) A person who desires to obtain information under the Act has to make a request in writing to the Public Information Officer with the prescribed fee.
- (iii) Public Authorities have to furnish the required information to the applicants through the designated Public Information Officers within the stipulated period.
- (iv) Persons belonging to Below poverty line are not liable to pay any fee.
- (v) The Public Information Officer shall provide the required information or reject the request within 30 days of the receipt of such request.
- (vi) When a request for information has been rejected, the Public Information Officer shall communicate to the petitioner
  - a) the reasons for such rejection;
  - b) the period within which an appeal against such rejection may be preferred; and
  - c) the particulars of the Appellate Authority.
- (vii) Any person who does not receive a decision on the request within 30 days or is aggrieved by a decision of the Public Information Officer, as the case may be, has the right to prefer an appeal within 30 days from the expiry of such period or from the receipt of such a decision before the Appellate Authority in each public authority.
- (viii) Where the information sought for concerns the life and liberty of a person, the same should be provided within forty eight hours of the receipt of the request.
- (ix) Every public authority is required to make voluntary disclosure of information of its functions which is to be updated every year.



## **2.2. Information**

As per Section 2(f) of the Right to Information Act, “information” means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

## **2.3. Public Authority**

As per Section 2(h) of the Right to Information Act, a ‘Public Authority’ means any authority or body or institution of self-government established or constituted

- a) by or under the Constitution;
- b) by any other law made by Parliament;
- c) by any other law made by State Legislature;
- d) by notification issued or order made by the appropriate Government and includes any-
  - i) body owned, controlled or substantially financed;
  - ii) non-Government organization substantially financed, directly or indirectly by funds provided by the appropriate Government;

It is mandatory for every Public Authority as defined under the Act to designate Assistant Public Information Officers (APIOs) / Public Information Officers (PIOs) and First Appellate Authority (FAA) to deal with the petitions received from the citizens and furnish information to them as per the provisions of the Act, failing which the officer concerned will be liable for penalty / disciplinary action as determined by the concerned Information Commission.

## **2.4. Right to Information**

As per Section 2(j) of the Right to Information Act, “right to information” means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to inspection of work, documents, records, taking notes, extracts or certified copies of documents or records, taking certified samples of material, obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device.

## **2.5. Obligations of Public Authorities**

Section 4 of the Right to Information Act states that

(1) Every public authority shall

(a) maintain all its records duly catalogued and indexed in a manner and the form which facilitates the right to information under the Act and ensure that all records that are appropriate to be computerised are, within a reasonable time and subject to availability of resources, computerised and connected through a network all over the country on different systems so that access to such records is facilitated;

(b) publish —

- (i) the particulars of its organisation, functions and duties;
- (ii) the powers and duties of its officers and employees;
- (iii) the procedure followed in the decision making process, including channels of supervision and accountability;
- (iv) the norms set by it for the discharge of its functions;
- (v) the rules, regulations, instructions, manuals and records, held by it or under its control or used by its employees for discharging its functions;
- (vi) a statement of the categories of documents that are held by it or under its control;
- (vii) the particulars of any arrangement that exists for consultation with, or representation by, the members of the public in relation to the formulation of its policy or implementation thereof;
- (viii) a statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for the purpose of its advice, and as to whether meetings of those boards, councils, committees and other bodies are open to the public, or the minutes of such meetings are accessible for public;
- (ix) a directory of its officers and employees;
- (x) the monthly remuneration received by each of its officers and employees, including the system of compensation as provided in its regulations;
- (xi) the budget allocated to each of its agency, indicating the particulars of all plans, proposed expenditures and reports on disbursements made;
- (xii) the manner of execution of subsidy programmes, including the amounts allocated and the details of beneficiaries of such programmes;
- (xiii) particulars of recipients of concessions, permits or authorisations granted by it;
- (xiv) details in respect of the information, available to or held by it, reduced in an electronic form;
- (xv) the particulars of facilities available to citizens for obtaining information, including the working hours of a library or reading room, if maintained for public use;

- (xvi) the names, designations and other particulars of the Public Information Officers;
  - (xvii) such other information as may be prescribed; and thereafter update these publications every year;
- (c) publish all relevant facts while formulating important policies or announcing the decisions which affect public;
- (d) provide reasons for its administrative or quasi-judicial decisions to affected persons.

**2.6. Public Authority to be addressed when the Information sought for in the Petition is held by more than one such Public Authority.**

Section 6(3) of the Act provides that where an application is made to a public authority requesting for an information which is held by another public authority or the subject matter of which is more closely connected with the functions of another public authority, the public authority to which such application is made, shall transfer the application or such part of it as may be appropriate to that other public authority and inform the applicant immediately about such transfer.

There may be cases in which a person of ordinary prudence may believe that the piece of information sought by him/her would be available with the Public Authority. In such cases, the applicant, makes a bonafide mistake of addressing the application to the Public Information Officer of a wrong Public Authority. On the other hand where an applicant addresses the application to the Public Information Officer of the Public Authority, which to a person of ordinary prudence, would not appear to be the concern of that Public Authority, the applicant does not fulfill his responsibility of addressing the application to the concerned Public Authority.

**2.7. Time Frame**

Section 7 of the Act lays down statutory time frame of 30 days for disposal of requests either for giving information or rejecting the same with reasons. The time frame for supply of information, which is related to the life or liberty of a person, has been fixed as forty eight hours. An appeal under sub-section (1) or sub-section (2) of Section 19 shall be disposed of within thirty days of the receipt of the appeal or within such extended period not exceeding a total of forty five days from the date of filing thereof, as the case may be, for reasons to be recorded in writing.

## **2.8.Exemption from Disclosure of Information**

Exemption from disclosure of information is covered under Section 8 of the Right to Information Act, 2005, is explained below:

- (1) Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen, -
  - (a) information, disclosure of which would prejudicially affect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence;
  - (b) information which has been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court;
  - (c) information, the disclosure of which would cause a breach of privilege of Parliament or the State Legislature;
  - (d) information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that larger public interest warrants the disclosure of such information;
  - (e) information available to a person in his fiduciary relationship, unless the competent authority is satisfied that the larger public interest warrants the disclosure of such information;
  - (f) information received in confidence from foreign Government;
  - (g) information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes;
  - (h) information which would impede the process of investigation or apprehension or prosecution of offenders;
  - (i) cabinet papers including records of deliberations of the Council of Ministers, Secretaries and other officers:

Provided that the decisions of Council of Ministers, the reasons thereof, and the material on the basis of which the decisions were taken shall be made public after the decision has been taken, and the matter is complete, or over:

Provided further that those matters which come under the exemptions specified in this section shall not be disclosed;

- (j) information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the State Public Information Officer or the Appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information:

Provided that the information which cannot be denied to the Parliament or a State Legislature shall not be denied to any person.

As per Section 9 of the Right to Information Act, 2005, without prejudice to the provisions of Section 8, a State Public Information Officer may reject a request for information where such a request for providing access would involve an infringement of copyright subsisting in a person other than the State.

As per Section 24(4) of the Right to Information Act, 2005, nothing contained in this Act shall apply to such intelligence and security organization being organizations established by the State Government, as that Government may, from time to time, by notification in the Official Gazette, specify:

Provided that the information pertaining to the allegations of corruption and human rights violations shall not be excluded under this sub-section:

Provided further that in the case of information sought for is in respect of allegations of violation of human rights, the information shall only be provided after the approval of the State Information Commission and, notwithstanding anything contained in Section 7, such information shall be provided within forty-five days from the date of the receipt of request.

#### **2.9. Protection of action taken in good faith**

As per Section 21 of the Right to Information Act, 2005, no suit, prosecution or other legal proceeding shall lie against any person for anything which is in good faith done or intended to be done under this Act or any rule made thereunder.

#### **2.10. Act to have over riding effect**

As per Section 22 of the Right to Information Act, 2005, the provisions of this Act shall have effect notwithstanding anything inconsistent therewith contained in the Officials Secrets Act, 1923, and any other law for the time being in force or in any instrument having effect by virtue of any law other than this Act.

### **2.11. State Information Commission**

As provided under Section 15 (1) of the Right to Information Act, 2005, the Government of Tamil Nadu constituted the Tamil Nadu Information Commission vide G.O. (Ms). No 988, Public (Estt I & Legislature) Department, dated 07.10.2005.

### **2.12.Powers and Functions of the State Information Commission**

The Right to Information Act, 2005, prescribes the powers and functions of the Commission under Sections 18, 19 and 20 in dealing with complaints, appeals and penalties respectively.

### **2.13.Disposal of complaints under Section 18 of the Right to Information Act, 2005**

(1) The State Information Commission shall, while inquiring into any matter under this section, have the same powers as are vested in a Civil Court while trying a suit under the Code of Civil Procedure, 1908, in respect of the following matters, namely:-

- (a) summoning and enforcing the attendance of persons and compel them to give oral or written evidence on oath and to produce the documents or things;
- (b) requiring the discovery and inspection of documents;
- (c) receiving evidence on affidavit;
- (d) requisitioning any public record or copies thereof from any court or office;
- (e) issuing summons for examination of witnesses or documents; and
- (f) any other matter which may be prescribed

Notwithstanding anything inconsistent contained in any other Act of Parliament or State Legislature, as the case may be, the State Information Commission may during the inquiry of any complaint under this Act, examine any record to which this Act applies which is under the control of the public authority, and no such record may be withheld from it on any grounds.

### **2.14.Disposal of Appeals under Section 19 of the Right to Information Act, 2005**

(1) Any person who, does not receive a decision within the time specified in sub- section (1) or clause (a) of sub-section (3) of Section 7, or is aggrieved by a decision of the State Public Information Officer, may within thirty days from the expiry of such period or from the receipt of such a decision prefer an appeal to such officer who is senior in rank to the State Public Information Officer in each public authority;

Provided that such officer may admit the appeal after the expiry of the period of thirty days if he or she is satisfied that the appellant was prevented by sufficient cause from filing the appeal in time.

- (2) Where an appeal is preferred against an order made by the State Public Information Officer under Section 11 to disclose third party information, the appeal by the concerned third party shall be made within thirty days from the date of the order.
- (3) A second appeal against the decision under sub-section (1) shall lie within ninety days from the date on which the decision should have been made or was actually received, with the State Information Commission.

Provided that the State Information Commission may admit the appeal after the expiry of the period of ninety days if it is satisfied that the appellant was prevented by sufficient cause from filing the appeal in time.

- (4) If the decision of the State Public Information Officer against which an appeal is preferred relates to information of a third party, the State Information Commission shall give a reasonable opportunity of being heard to that third party.
- (5) In any appeal proceedings, the onus to prove that a denial of a request was justified shall be on the State Public Information Officer who denied the request.
- (6) An appeal under sub-section(1) or sub-section(2) shall be disposed of within thirty days of the receipt of the appeal or within such extended period not exceeding a total of forty five days from the date of filing thereof, as the case may be, for reasons to be recorded in writing.
- (7) The decision of the State Information Commission shall be binding.
- (8) In its decision, the State Information Commission has the power to -
  - (a) require the public authority to take any such steps as may be necessary to secure compliance with the provisions of this Act, including:-
    - (i) by providing access to information, if so requested, in a particular form;
    - (ii) by appointing a State Public Information Officer;
    - (iii) by publishing certain information or categories of information;
    - (iv) by making necessary changes to its practices in relation to the maintenance, management and destruction of records;
    - (v) by enhancing the provision of training on the right to information for its officials;
    - (vi) by providing it with an annual report in compliance with clause(b) of sub- section (1) of Section 4;
  - (b) require the public authority to compensate the complainant for any loss or other detriment suffered;
  - (c) impose any of the penalties provided under Right to Information Act;
  - (d) reject the application.

### **2.15. Penalties under Section 20 of the Right to Information Act, 2005**

- (1) Where the State Information Commission at the time of deciding any complaint or appeal is of the opinion that the State Public Information Officer, has, without any

reasonable cause, refused to receive an application for information or has not furnished information within the time specified under sub-section (1) of Section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of two hundred and fifty rupees each day till application is received or information is furnished, so however, the total amount of such penalty shall not exceed twenty five thousand rupees:

Provided that the State Public Information Officer, shall be given a reasonable opportunity of being heard before any penalty is imposed on him:

Provided further that the burden of proving that he acted reasonably and diligently shall be on the State Public Information Officer.

- (2) Where the State Information Commission, at the time of deciding any complaint or appeal is of the opinion that the State Public Information Officer, has, without any reasonable cause and persistently, failed to receive an application for information or has not furnished information within the time specified under sub-section (1) of Section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall recommend for disciplinary action against the State Public Information Officer, under the service rules applicable to him.

### **CHAPTER - 3**

#### **3.1. Rules Notified under the Right to Information Act, 2005**

As per Section 27(1) of the Right to Information Act, 2005, the appropriate Government may, by notification in the Official Gazette, make rules to carry out the provisions of this Act. Similarly, as per Section 28(1) of the Right to Information Act, 2005, the competent authority may, by notification in the Official Gazette, make rules to carry out the provisions of this Act.

#### **3.2.Fees to be paid under the Tamil Nadu Right to Information (Fees) Rules, 2005**

The Government of Tamil Nadu vide G.O.Ms.No.989, Public (Estt.I&Legislature) Department, dated 07.10.2005, has notified the Tamil Nadu Right to Information (Fees) Rules, 2005. Subsequently, certain amendments were issued to the said rules vide G.O.Ms.No.1012, Public (Estt.I& Legislature) Department, dated 20.09.2006, G.O.Ms.No.72, Personnel and Administrative Reforms (AR III) Department, dated 20.03.2007 and G.O.Ms.No.12, Personnel and Administrative Reforms (AR III) Department dated 18.01.2011. The fees to be paid under the Tamil Nadu Right to Information (Fees) Rules, 2005 are as follows:

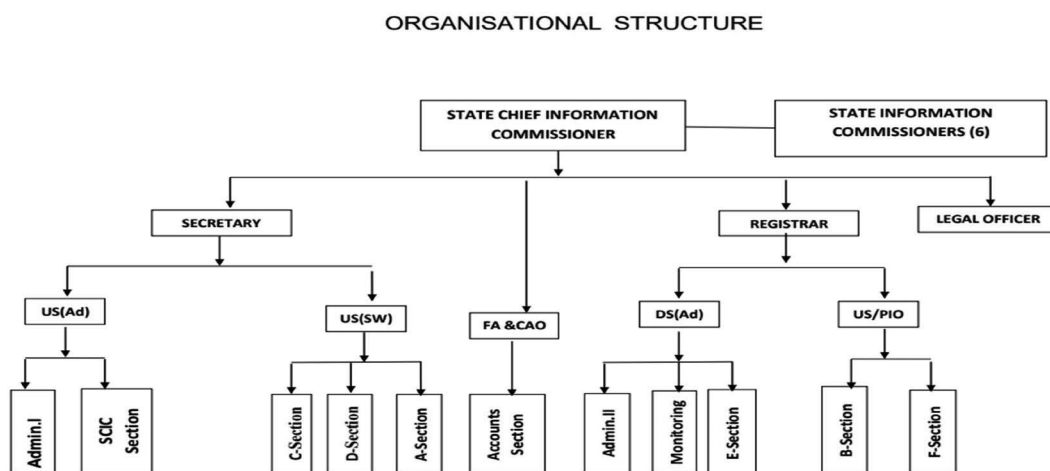

## **CHAPTER – 9**

### **9.1.Preparation of Annual Report – 2021**

As per Section 25(1) of the Right to Information Act, 2005, the Commission is required to prepare a report after the end of each year, on the implementation of the provisions of this Act during that year and a copy thereof is to be forwarded to the appropriate Government, which in turn will lay it before the State Legislature.

As per Section 25(2) of the Right to Information Act, 2005, each Ministry or Department shall, in relation to the public authorities within their jurisdiction collect and provide information to the State Information Commission, as is required to prepare the report. The Annual Report, 2021, has been prepared based on the particulars received from the Public Authorities on the implementation of Right to Information Act during the year 2021.

The Public Authorities of this State have handled 3,81,919 Right to Information applications during the year 2021, which is 68,256 applications higher than that were handled during the year 2020.

### **9.3. Disposal of First Appeals by the First Appellate Authorities**

During the year 2021, a total number of 41,729 first appeals were handled by the first Appellate Authorities, out of which 37,894 first appeals were disposed by providing information. The number of first appeals rejected was 1,099 and the pending number of first appeals as on 31.12.2021 was 2,736.

## **CHAPTER – 11**

### **11.1.Recommendations of the Commission to the Government**

In the previous Annual Reports, the Commission had made several recommendations to the Government under Section 25(5) of the RTI Act, 2005. The Commission reiterates the following recommendations, for consideration of the Government.

1. In order to provide proper and accurate information to the Petitioners by the Public authorities, it is recommended that a Comprehensive Information Management System should be developed by each public authorities for storage and retrieval of data and other information.

2. It is recommended that the Government Departments may take necessary action to upload the Government Orders and important Government letters / Instructions in their respective websites, as and when issued by them, which will be most useful to the public and Government officials.
3. The present staff strength of the Tamil Nadu Information Commission which was sanctioned at the time of formation of the Commission is not equal with the volume of work handled by the Commission, due to the increasing number of the Right to Information Second Appeal / Non Compliance / Complaints petitions. Hence, it is recommended for increasing the staff strength of the Tamil Nadu Information Commission at each and every level, which enable the Commission to discharge its functions in an effective manner.
4. As per section 19(6) of the RTI Act, 2005, Appeal shall be disposed of within thirty days of the receipt of the appeal or within such extended period, not exceeding a total of forty-five days from the date of filing thereof as the case may be for reasons to be recorded in writing. It is observed that most of the First Appellate Authorities are not furnishing the information as per the above provision of the Act. The failure on the part of the First Appellate Authorities resulted in the increasing number of Second Appeals to the Tamil Nadu Information Commission by the RTI petitioners. Hence, the Commission therefore reiterates that the Government should ensure that the Appellate Authorities in every Public Authority should comply the Appeal provisions of the Right to Information Act, 2005.
