## <u>Order</u>

This case camp up for hearing on 22-10-2024 and the Commission passed the following orders.

Hence, the new Public Information Officer, Tmt.Regina is directed to obtain the information from the Collectorates of Krishnagiri and Dharmapuri and send to the petitioner within two months by registered post with acknowledgement card and submit the Acknowledgement Card and copy of reply on 08-01-2025 before the Commission.

As regards the Complaint Petition, the petitioner alleged that no reply was given to him and wants action against the Public Information Officer. But a perusal of records show that a reply was sent on 27-07-2022 to the petitioner. Hence the complaint petition is treated as closed."

2. On 08/01/2025 the Public Information Officer was absent. PIO was directed to submit the explanations for her absence. Again, this case was taken up on 26-02-2025 and the Public Information Officer appeared and submitted the copy of reply/information dated 30/12/2024 sent to the petitioner and also the registered postal acknowledgement card as proof of receipt of the information by the petitioner. Hence, the Second Appeal is treated as closed. The Public Information Officer also

submitted her explanations for the show cause notice issued for her absence on 08/01/2025.

3. The explanation obtained from Thirumathi / Selvi K.Regina, Public Information Officer / Special Tahsildar (Land Acquisition), Housing Scheme, TNHB, Hosur Housing Unit, Hosur has been reviewed and it is accepted by the Commission. Hence, further action is dropped against her.
